INTRODUCTION

Each year, the department assesses its accomplishments and its shortcomings all as a means to provide better services to the community in a more efficient and effective way while, at the same time, always trying to maintain and hopefully increase our officers' morale. As you read through this report, I hope that you notice that the Fairfield Police Department truly goes above and beyond in all of its law enforcement and community policing initiatives, far surpassing other police departments of comparable size. Please take note that the pages of this report are nearly equally divided between our enforcement activities and our community policing and charitable activities. While it is the goal of most police departments to try and come close to striking such an even balance between the two, this department has actually achieved it.

In 2023, while the department saw many things remain the same, there were also many ventures and initiatives that were new and exciting. One of these projects included a collaboration with the Clifton Police Department and a British television production company in producing a television series for Paramount+ featuring motor vehicle enforcement here in the United States and by the Fairfield Police Department. Many of our officers participated and we are still anxiously awaiting the series premiere.

This year, there were a number of assignments made that have and will benefit the department from both a short and long term perspective. Most noteworthy was the transition of the Office of Emergency Management to now be located with the police department and in appointing Lt. Casendino as the emergency management coordinator. At the end of the year, his and the department's capabilities were put to the test when major flooding was predicted for the township in December. The department mobilized a full recall of its officers and went into an emergency operations mode. The overall effectiveness of the management of this emergency from those emergencies of the past was immeasurable, proving that this new arrangement was the best way to go.

In 2023, Officer Stacy Chiarolanza was assigned as the department's public information officer. Her selection to this position seemed a natural progression given that she was the officer providing the public with information over the department's various social media platforms. Now she is the face of the department in front of the cameras and is growing into this role exponentially and has done a great job.

In 2023, Detective Rick Alves was assigned to the New Jersey State Police Auto Theft Task Force from January until November. He was only removed when enforcement philosophies between the ATTF and the department differed greatly. But during his time there, he garnered valuable experience that already has aided some of our local stolen car and burglary investigations and was an integral part in recovering vehicles stolen from Fairfield this year in an unprecedented time.

As we take an overall look at the department's statistical activities, we do notice both favorable and unfavorable items for us. What is clear is that the department's calls for service, enforcement activities and investigative activities that reflect the daily actions of our officers were all higher in 2023 than they were in 2022. These include such things as computer-aided dispatch entries, case activity, call activity, background investigations, 9-1-1 emergency calls for service, arrests, DUI arrests, summonses, and motor vehicle stops.

An analysis of our major crime categories indicates burglaries, criminal mischief, simple assaults, and domestic violence cases are all down, while thefts, motor vehicle thefts, frauds, and aggravated assaults are all up.

An analysis of our budgetary items indicates that the department has reduced its operational spending over the last three years. Unfortunately, it did not have the same success in curbing overtime costs. This will be addressed later in this report and hopefully in 2024 because of the table of organization revisions being implemented in 2024.

In the area of professional standards, the analysis indicates that the numbers are all trending in the right direction. The number of internal affairs complaints handled, the number of uses of force incidents and the number of motor vehicle pursuits undertaken have all declined from the previous year.

As we approached the end of 2023, I felt there was a need to conduct a top to bottom assessment as it related to the efficient and effective operations of the police department and whether or not what I initiated when I first became chief over eight years ago, were still viable and working like I wanted them to. As such, I decided it was once again time for the department to go in a different direction. In 2024, a new table of organization will be implemented which has been designed to bolster the number of officers on a patrol squad and to put more officers on our Fairfield streets. In doing so, I am hoping to reduce crime through deterrence and hopefully improve our operating and overtime costs. Only time will tell if this strategy was effective when we do a similar analysis at the end of 2024.

In 2024, the State of New Jersey is implementing the legislated and long awaited police licensing program which now requires that police officers receive a license from the Police Training Commission in order to be permitted to work in law enforcement. These licenses are valid for a three year period and will be constantly evaluated by the state. This, coupled with the general public's view of law enforcement and their scrutiny of their activities, the softening of laws by legislators, low compensation and a number of other items is making recruitment and retention of qualified candidates and officers very challenging. In that same vein, our officers are truly a caring and professional group of individuals who always go way beyond what is expected of them and notably above what many others in our profession would even consider doing if asked.

I have worked for the Township of Fairfield as a law enforcement officer for over 39 years. That experience, coupled with what I stated above about the problems with recruitment and retention of officers and given how professional and dedicated our current officers remain to this community, is why it is of paramount importance that the township does everything possible to assure that the position of a law enforcement officer in Fairfield remains a viable and competitive one with proper compensation and opportunity. Much has been done over the last eight years to increase morale and professional opportunities for our workforce. But without providing necessary compensation that just meets those of our neighboring departments of comparable size and activity, it is my fear that anything less may bring about the possibility of not obtaining qualified people to carry on the long standing professional reputation that this department has enjoyed since its inception.

For the third straight year, the police department has spent under the amount budgeted to them. Prior to this timeframe, the township's CFO would need to shift money to our department as early as November. I credit this consistent reduction in better oversight of the budget by Lt. Casendino who I assigned to assure this occurred.





2-TABLE OF ORGANIZATION

In 2023, the Table of Organization was once again amended to include the newly created Emergency Management Section commanded by Lt. RJ Casendino. This section is found within the Operations Division. I believe that, by the township placing the emergency management function within the full-time staffed police department, it will make for better supervision of emergencies.

The chief continued to hold weekly meetings on Wednesdays with his executive staff. These meetings have proven to be vital to formulating strategic planning, addressing problems in a timely manner and for all of these officers to roundtable and exchange information from each of the disciplines that they oversee. In addition, this group has been painstakingly reviewing all department policy and procedure prior to it being reviewed by the general membership.

Included in this report is the table of organization that existed for 2023 and the new table of organization that has been implemented for 2024. After a full review of operations within the department, the Chief of Police felt it necessary to reassign personnel to better manage the department from both an operational and financial perspective. This re-evaluation of personnel assignments concluded that some of the items put in place approximately eight years ago were not as beneficial to the department and the township as they once were. The following changes should be specifically noticed:

Elimination of Special Enforcement Unit (SEU)- When this unit was first implemented, it was done so for a variety of reasons. First and foremost, it provided for a specialized unit who could target specific problems in the area of motor vehicle enforcement occurring within the township between Monday-Friday, from 6:30 AM until 11:00 PM. Assignments to this unit were done by seniority which benefited these senior officers as they no longer had to work midnight shifts or weekends. The township also benefitted as there was an increase in the issuance of motor vehicle summonses which resulted in an increase in fines collected.

Due to shortages in the patrol squads, SEU officers very often were not free to conduct the traffic details they once did but instead counted towards mandatory minimum staffing. Additionally, because of additional bail reform legislation, the municipal court has a decreased collection rate of the fines generated by SEU officers. Therefore, in 2024, the SEU will be dissolved, and the officers will be assigned to patrol squads.

Elimination of Task Force Officers- When the Chief of Police took command of the department approximately eight years ago, stagnation was rampant throughout the department. As a way to help motivate officers and to benefit the citizenry and the township, he chose for the department to participate in various task forces. The most recent included the Drug Enforcement Administration (DEA) and the New Jersey State Police Auto Theft Task Force (NJSP ATTF). Insofar as the former is concerned, our officers greatly contributed to the united fight against illegal drugs that affect the entirety of the United States and our area as well. They have been a part of significant money seizures for which the department will continue to receive portions from into the future.

Our partnership with the NJSP ATTF was equally productive and even more visible to our community in helping to recover stolen vehicles from Fairfield and in making a dent in the auto theft epidemic that plagues our state. This partnership may have continued further had there not been differences in enforcement philosophies between the NJSP and Fairfield police command.


Either way, it seems like the right time for all Fairfield police personnel to be recalled so greater emphasis on enforcement and crime prevention can be maintained closer to home. Hopefully, in

the future, we can re-establish these partnerships and participate in task force assignments as it provides our officers with invaluable experience and great opportunities.

- Increased Patrol Squad Sizes- With the reallocation of personnel from task forces and SEU and
 the proposed hiring of a total of four dispatchers to rotate within patrol squads, this should greatly
 help with decreasing overtime costs, assuring sufficient officers are present on shifts, help deter
 crime and give supervisors greater opportunity to supervise.
- Increased Staffing in Investigative Section- The staffing in the Investigative Section has in
 essence stayed flat for the last twenty-five years even though the number of cases that detectives
 investigate has increased dramatically along with the complexity of the types of cases they
 investigate. With the same reallocation of personnel from task forces and SEU, it provides for the
 opportunity to add an additional detective to help offset individual detective caseloads.



TABLE OF ORGANIZATION





3- PERSONNEL

PROMOTIONS/ASSIGNMENTS

There was one promotion made in 2023. On June 26th, Sgt. RJ Casendino was promoted to the rank of lieutenant and was assigned as the section commander of the newly created Emergency Management Section. He was also named as the township's emergency management coordinator. On ***, Sgt. Thomas Myers was reassigned from his position in the department's Special Enforcement Unit to the Professional Standards Section. In January, Officer Rick Alves was assigned to the New Jersey State Police North Auto Theft Task Force. He remained on this assignment until November.

In 2023, Officer Stacy Chiarolanza was assigned as the department's Public Information Officer. Throughout the year, she has done an excellent job in establishing relationships with many news outlets. She has done on camera interviews with many of these agencies to include ABC News, Fox Weather, and News12 NJ to name just a few.

RESIGNATIONS/TERMINATIONS

The department had five resignations in 2022 involving one dispatcher and four SLEO II officers. They were as follows:

- <u>Dispatcher Felipe Maldonado</u>- resigned on March 28th to pursue dispatching career with North Caldwell Police Department.
- <u>SLEO II Gia Gagliano</u>- resigned on July 5th in order to pursue a full time police position with the North Caldwell Police Department.
- <u>SLEO II Derek Michelman</u>- resigned on September 1st, prior to completing the police academy, in order to pursue a full time position with the Hardyston Police Department.
- <u>SLEO II Ryan Vath</u>- resigned on September 1st, prior to completing the police academy, in order to pursue a full time position with the West Milford Police Department.
- <u>SLEO II Jacob Mangieri</u>- resigned on October 8th in order to pursue a full time police position with the New Jersey Park Police Department.

HIRINGS/APPOINTMENTS

On August 23rd, the department hired SLEO II Juan Barasso and appointed retired Orange Police Lieutenant Orlando Soto to serve as its chaplain.

COMMENDATIONS

Water Rescue

<u>Honorable Service Citation</u> Corporal Steven D'Argenio

On September 29, 2023, the parking lot of 16-18 Passaic Avenue had flash flooding trapping a motorist in his vehicle in rising water. The police and fire departments were contacted and responded. Any water

rescue presents inherent risk in that there can be open manhole covers, chemicals in the water, and sink holes to name a few. Corporal Steven D'Argenio, a member of the department's Emergency Response Team and who has swift water training, had completed a busy night shift and was about to go home when this call came in. He waded through the waist high water and carried the motorist to safety. His actions brought national acclaim to the Fairfield Police Department and to the law enforcement profession. He was commended in a phone call by both Governor Phil Murphy and Congresswoman Mikie Sherrill.

It should also be noted that Corporal D'Argenio also received the High Level Excellence Award at the United Nations 1000 Shades of Women Foundation Awards gala on December 9th.

Arrest of Armed Suspect

Meritorious Service Citation
Officer Patrick Reynolds, Officer Katrina Guevara

On October 14, 2023, the police department received a call from the staff of the LaQuinta Inn and Suites of an unwanted guest in the lobby who refused to leave. Officers Patrick Reynolds and Katrina Guevara responded to the call and began speaking with the suspect. During their initial investigation, it was immediately determined that the suspect had active warrants issued by Haledon and the Passaic County Sheriff's Department. At this point, the suspect began to flee on foot, and he was pursued by the officers. After a short distance, the suspect stopped and complied with the officers' directions. He was found to be armed with a loaded 9mm handgun containing a prohibited extended magazine. This suspect was found to have had 12 prior arrests.

Employee of the Year
Dispatcher Joseph Piccoli

In 2023, Chief Manna instituted an Employee of the Year Award. The winner of the award would be selected by the members of the department to an employee who exemplified a strong work ethic, instilled esprit de corps, was willing to pitch in and who just did their job extremely well. The overwhelming selection for this year's inaugural award was Dispatcher Joseph Piccoli. The award was presented to him at the Police Foundation's annual gala.



4- OPERATIONS DIVISION ACTIVITIES

OPERATIONS DIVISION COMMANDER

Captain Daniel Dias

In 2023 the ALPR's that have been strategically positioned throughout the township have continued to be an invaluable tool in quickly identifying and alerting our officers to the presence of a criminal element within our borders throughout the course of the year. This technology once again greatly assisted members of the Patrol Section in better locating this same criminal element. This has most definitely helped to deter further crime within our jurisdiction and lead to numerous criminal apprehensions that would not have otherwise occurred without the ALPR's.

Members of our ALICE training unit continued in 2023 to provide valuable active shooter response training to numerous businesses within our community exhibiting a continuation of our excellent relationship with members of our business community. This training will most definitely better prepare these members of our community in the event of an unforeseen emergency no matter the location of the occurrence.

As we do each and every year as an agency at the beginning of September our ALICE training unit provided active shooter response training to the entire staff from Stevenson and Churchill Schools at the annual professional development day hosted at Churchill School in the main gym. This training conducted by Detectives Daniel Moran and Rick Alves was both timely and informative and well received by the school staff.

As in the past, the security of the schools within our jurisdiction remains a high priority. As such, our agency conducted active shooter and lockdown drills in conjunction with the respective administration and staffs at Churchill Elementary School, Stevenson Elementary School, The Gramon School, New Beginnings School, Essex Campus Academy, and the Banyan School during the year. This continued coordination better ensures that all procedures and protocols related to potential threats at our schools are closely followed, thus resulting in an optimal level of preparedness in an unforeseen emergency.

Members of the Operations Division, to include patrol officers and most notably SLEO II's, continued to provide traffic control and security during township events during the course of the year. These events included National Night Out Event, the Winter Wonderland Event, the Columbus Day Event, the St. Thomas More Carnival and the 4th of July fireworks event to name a few. Security and traffic control was also provided at the Fairfield Recreation Complex for various sporting events to include the Fairfield Falcon level A, B and C football games and recreation soccer games.

Our excellent working relationship with the Livingston Police Department continued as we were able to utilize the Livingston Firearms Range for numerous days during the course of 2023 for various firearms drills to include rifle and MP5 qualifications and tactical drills for which we as an agency are truly grateful as range time is difficult to secure.

As stated in a number of the monthly reports for 2023, Reloaderz shooting range located in Wayne, NJ continued to show their support of our agency by providing us with training opportunities and range time in December ensuring that our officers are able to continue to perform at the highest level when it comes to firearms proficiency, as range time is more and more difficult to secure. This was again evident as they provided us with multiple days of range time to complete mandatory firearms qualifications during the course of 2023.

In order to expand and infuse younger members of the department into the Emergency Response Team tryouts for the unit occurred during 2023 consisting of physical fitness standards, as well as firearms proficiency standards being met for consideration for the team. A significant number of officers expressed interest in joining the team and upon completion of the demanding process the following officers were selected to become the new team members: Officer James Ciampi, Officer Jayson Sickles and Detective Michael Tilton. These individual officers should be commended for maintaining a high level of firearms proficiency and personal physical fitness which solidified their selection.

The Fairfield Township Summer Camp Program hosted at the Fairfield Recreation Complex began on June 26th and ran through the beginning of August, every Monday through Friday, with traffic control and periodic safety checks conducted by members of the Fairfield Police Patrol Section on a daily basis.

The summer school educational program was in session at the Stevenson School from July 5th through August 4th with security for the staff and students provided by SLEO III Joseph Prinzo. These sessions took place between 9:00am and 1:00pm daily.

As we do every year as an agency, members of the command staff attended the annual September 11th ceremony held at the Essex County Eagle Rock Reservation in class A uniforms to pay tribute to all those who perished as a result of the terrorist attacks that took place on that fateful day. This event was very well attended by the public and our presence there was definitely well received and appreciated by the attendees at the ceremony.

Members of the Operations Division, to include patrol officers, SLEO II's and SLEO III's, continued to provide school security at Churchill and Stevenson elementary schools, court security at the Fairfield Municipal Court and security at Township events to include the S'Mores Night hosted at the VFW on December 8th and the annual Winter Wonderland event at the Fairfield Recreation Complex on December 9th. Our current SLEO II's also continued to be a great asset by supplementing staffing for the patrol division during the month of December when needed.

During January, DUI enforcement details strategically planned during the month utilizing DDEF funds led to a significant increase in summons production.

As always, the Patrol Section continued to assist with numerous funeral details during the course of the year, which you are all aware is greatly appreciated by the families of the deceased and reflects well upon our agency.

4A-PATROL SECTION ACTIVITIES

CELLBLOCK MANAGEMENT

MEMBERS

In 2023, the Fairfield Police Department housed a total of 213 prisoners - 158 males and 55 females. This represents a 28% increase on the 2022 total of 166 prisoners. In addition, we housed a total of 9 juvenile prisoners – 7 males and 2 females. In 2022 we housed no juvenile prisoners.

The Department did an exemplary job at incident-free confinement. There were no incidents of attempted suicide nor were there any prisoners held for over 24 hours. On average a prisoner was held in our custody for

approximately 3 hours and 6 minutes. This represents a 20% decrease in the average confinement time from 2022.

Cell #1 was converted to a bunk cell from a bench cell in accordance with the request from the New Jersey Department of Corrections inspection of 2022.

DRONE UNIT

ACTIVITIES

The Drone Unit had many accomplishments in 2023. It conducted 69 total flights. The purpose of these flights was wide ranging. Our drone was deployed, not only in our town, but in surrounding towns when they were in need. The following is a list of deployments:

Fairfield Deployments:

- Conducted a search for a missing individual with dementia
- Conducted a search for a missing autistic juvenile
- Conducted flights to search the Big Piece Meadows for a possible person in distress.
- Conducted flights to assess flooding conditions
- Conducted numerous flights at community events. Some of these flights were demonstrations to show
 the public what our capabilities are, and some are flights to monitor the event in a way we were never
 able to in the past.

Mutual Aid Deployments:

- <u>DEA Assistance</u>- The unit assisted the DEA and Task Force Officer Bisciotti with surveillance and obtaining license plates for an ongoing investigation.
- Wayne PD- Assisted Wayne police for the report of a body in the Passaic River
- West Caldwell PD- Assisted West Caldwell with the search of a missing person.
- <u>Cedar Grove PD</u>- Assisted Cedar Grove with suspicious noises coming from the reservoir.

TRAINING

- January The unit qualified with their firearms and participated in shooting drills at Reloaderz.
- <u>February</u> The ERT ran its selection process for officers who were interested in the unit. The
 candidates were brought to the range to shoot a qualification course with their handguns. The
 candidates also attempted an ERT physical exam. The results were recorded and used for the
 selection process.
- March The ERT selected new members Det. Tilton, PO Ciampi and PO Sickles. All members attended Close Quarters Battle training March 27th – 29th at Picatinny Arsenal hosted by Northern Red.
- April Members of the Emergency Response Team attended the New York Tactical Officers
 Association conference April 24th 28th. The courses attended included tactical combat casualty
 care, dominating from bad positions on the ground, combat mindset lecture, chemical munitions
 instructor certification, instructor development workshop for firearms instructors, warrant planning
 & preparation and solo active shooter response. This conference allowed the members of the
 ERT to receive quality training from some of the best instructors around the country.
- May Members of the Emergency Response Team qualified with their rifles at the Livingston range May 24th through the 26th. They all passed the minimum standards needed for the ERT.
- <u>June</u> Members of the Emergency Response Team participated in an active shooter training at West Essex Middle School on June 20th. The training was hosted by the North Caldwell Police Department. The Livingston Range was used by members of the ERT to work on shooting precision.
- <u>September</u> Capt. Dias and Lt. Nyhuis visited a shooting range in Byram, NJ that is owned by a Fairfield business. The owner graciously offered the range to our ERT for training in the future.
- October Members of the Emergency Response Team attended a four-day CQB train the trainer course in Cedar Grove. This training included officers from West Essex towns and was instructed by the NJ State Police.
- November Members of the Emergency Response Team qualified with their rifles at Gun for Hire range on November 22nd and 24th.
- <u>December</u> ERT members worked on precision shooting with their handguns and rifles at Reloaderz on 12/4-12/6.

EQUIPMENT

The Emergency Response Team acquired three new rifles for its new team members. The new lights and sights for the new ERT members' rifles arrived and were installed.

DEPLOYMENTS

• <u>Independence Day Celebration</u>- On June 29th, ERT members provided security at this event at Hollywood Park.

- <u>National Night Out</u>- On August 1st, ERT members provided security at this event at Hollywood Park.
- Water Rescue- On September 29th, ERT member Cpl. D'Argenio was deployed for swift water rescue and assisted a motorist out of his vehicle during a flash flooding incident on Passaic Avenue.
- <u>Columbus Day Celebration</u>- On October 8th, ERT members provided security at this event at Hollywood Park.
- <u>Winter Wonderland</u>- On December 9th, ERT members provided security at this event at Hollywood Park.
- <u>Flood Event</u>-Between December 19th-23rd, ERT swift water rescue members were deployed to conduct rescue operations during a townwide flood.

ACTIVITIES

Members of the Fairfield Police Patrol Section responded to 839 calls for medical assistance throughout 2023, a 1% increase in call volume over 2022, where officers responded to 831 calls for medical aid. Overall, the Patrol Section has responded to an average of 841 calls for medical assistance per year over the past five years.

FIREARMS TRAINING UNIT

ACTIVITIES

This year, the Firearms Unit successfully qualified every member of the department and remained complainant with all Attorney General guidelines. Every member's service weapon was fully inspected and cleaned after all qualifications and the firearms unit found no weapon malfunctions or defects. Any equipment that failed during the calendar year was repaired or replaced.

Finding gun ranges that offer availability and the proper distance depending on the weapons being fired has proven to become even more difficult. The Firearms Unit has been actively researching options for 2024 as we anticipate this being an issue.

Armorer certifications were kept current with re-certification training taking place for Colt Rifle and H&K MP-5 armorers. The firearms unit added (4) new instructors to the unit and this has helped tremendously with qualifications, training, and weapon maintenance.

Three new rifles were purchased, assigned, and placed into service. Four more rifles were ordered late in the year and pending arrival. The departments old M16 rifle was upgraded with a new upper receiver

and made serviceable. With the addition of these new rifles, armory storage needed to be addressed, therefore, the company that did the armory during renovations, Modern Office Supply, came in and is preparing a quote for the updates we need. That quote is still pending.

Ammunition continues to be in short supply and during 2023, the entire surplus of ammunition was used again. We were able to place new orders which arrived and resupplied our stock which we plan to add to in 2024 to keep us ahead of the curve.

ALICE training has continued to be offered to our community's businesses and schools. Annual training took place with our township schools at the beginning of the year and one local business took advantage of our service and held a training session for all of their employees.

Lastly, a complete inventory of all department owned weapons was conducted and all weapons are accounted for.

SCHOOL SECURITY UNIT

SPECIAL ENFORCEMENT UNIT

ACTIVITIES

The Special Enforcement Unit (SEU) continued its high levels of productivity during 2023.

Some of the statistical accomplishments include the issuance of (1,739) summonses, (202) vehicles impounded, and (99) escorts for funeral services. SEU conducted (229) directed enforcement details addressing speeding complaints on residential roadways, stop sign violations, and motorists passing stopped school buses. Throughout the year, Unit members constantly supplemented patrol-staffing coverage and alleviated overtime.

TRAFFIC RE-CONSTRUCTION/PLAN REVIEW/GRANT UNIT

MEMBERS

ACTIVITIES

During 2023 there were no serious crashes that required specialized investigation and the unit reviewed five traffic safety plans. We were awarded two out of four traffic grants our agency was eligible for.

Federal/State Grant Enforcement Activity was as follows:

- <u>Distracted Driving Crackdown April 1st- April 30th</u> there were 211 motor vehicle stops with 200 motor vehicle summonses issued.
- <u>Drive Sober or Get Pulled Over Statewide Labor Day Crackdown August 18th- September 4th There were 82 motor vehicle stops with 75 motor vehicle summonses issued.</u>

<u>Drunken Driving Enforcement Fund (DDEF) Activities were as follows:</u>

The expenditure of DDEF money is extremely regulated by the State of New Jersey, more so since 2021. Exactly 50% of the funds must be used for enforcement. The other portions of the funds can be used to purchase a limited number of approved items. In any case, the State of New Jersey has made it clear that agencies will no longer be able to hoard its DDEF money as they will not receive additional funding if they choose to do so. Future fund amounts are based upon DUI convictions, not arrests. Our DDEF Account ending balance for 2023 is \$18,000. The following reflects the use of DDEF money in 2023:

- <u>Purchase of Retroreflective Uniform Shirts</u>- In the beginning of the year Sgt. Rasmussen was
 given approval by the state to use \$6,192 from our DDEF Account to purchase long sleeve
 retroreflective uniform shirts for the entire department. DUI Enforcement Details from our DDEF
 Account:
- January DUI Details (5 shifts)- there were 45 motor vehicle stops with 40 summonses issued.
- February DUI Details (2 shifts) there were 28 motor vehicle stops with 16 summonses issued.
- March DUI Details (10 shifts) there were 30 motor vehicle stops with 19 summonses issued.
- June DUI Details (2 shifts) there were 21 motor vehicle stops with 21 summonses issued.

4B- EMERGENCY MANAGEMENT SECTION ACTIVITIES

On June 26th, Lt. Casendino was appointed the OEM Coordinator for the township. Upon being appointed he began by evaluating the township's Emergency Operations Plans. With the assistance of the Chief, we were able to reformat and update most of the (19) emergency annexes. By the end of 2023, only (3) annexes remain.

EMERGENCIES

• Flash Flooding- On September 29th, Fairfield experienced severe flash flooding on Passaic Avenue. Several vehicles became disabled in flood waters. Our swift water rescue team was

deployed, and multiple people were rescued from the high flood waters. The flash flooding lasted a few hours and ultimately receded without any further issues, damage, or injuries.

• <u>Flash & Sustained Flooding</u>- On December 18th, Fairfield experienced severe flash flooding from a coastal rainstorm. Once again, we experienced severe flash flooding in the area of Passaic Avenue. Several roads in town were impacted by the flooding and closed due to the 5" of rain that fell in a very short time. The police department conducted (3) vehicle rescues during the flash flooding event.

Once the flash flooding receded on December 18th, the Passaic River was forecast to reach major flood stage on December 20th (21.9'). On December 18th, a local state of emergency was declared for Fairfield due to the projected major flooding. The police department was put on a full recall for December 19th and entered into flood operations starting at 0700 hours.

During this flooding event, the river ultimately crested at 21.52" on December 20th. Fairfield experienced many road closures and street flooding. The Office of Emergency Management held daily briefings with members of the police department command staff, township department heads and county and state officials from December 18th-20th. There were a total of (26) vehicle and house rescues during this emergency. Luckily the township only experienced minor damage to residences and businesses. On December 22nd, the emergency order was rescinded, and the township went back to operating normally.

TRAINING:

Since June Lt. Casendino has attended several OEM/emergency response training courses associated with this position. These trainings are detailed below:

- June 2023- Flood Mitigation Workshop- NJIT
- June 2023- Essex OEM Workshop
- September 2023- Dam Safety Workshop
- September 2023- Essex OEM Workshop
- November 2023- PSE&G Gas Safety
- December 2023- Essex OEM Workshop

FINANCIAL:

Once taking over as OEM Coordinator, Lt. Casendino was made aware of several FEMA claims that the township currently had open. He coordinated with our state representatives on completing these claims in order to get the township reimbursed from these past emergencies. They include:

- Hurricane Ida- September 2021- \$92,000
- COVID- March 2020-July 2022- \$310,045

As of December 31st, the COVID-19 claims are approved and pending payment. The Hurricane IDA claim is still held up with FEMA. Lt. Casendino has already completed our second appeal due to additional paperwork being needed from the time the initial claim was put in. We received our \$10,000 EMAA grant for 2023 by completing all of the requirements for this project.

2024 PLANS:

In 2024, the Office of Emergency Management will develop improved planning and training exercises to better equip the township for different types of emergencies. These are detailed below:

- Quarterly Meetings with OEM Team- These meetings will be used to plan and map out different types of emergencies the township may face. We will also use this time to talk about past events and how we can improve on them.
- <u>Budgeting</u>- Trying to better budget for potential emergencies since most are not reimbursable by aid money. Also creating a more strategic capital budget for OEM purchases.
- Expanding OEM into its True Purpose- OEM is and must be made into more than a flood response. The Office of Emergency Management umbrella is very broad and extends to many different areas such as active shooters, migrant refugees, large scale fires etc. We want to at least start working on planning and awareness for these types of events.



5- SPECIAL SERVICES DIVISION ACTIVITIES

SPECIAL SERVICES DIVISION COMMANDER

Captain Charles Zampino

In 2023, the Special Services Division started a project with the West Essex Police Departments to purchase and install ALPR cameras throughout the West Essex communities. During this time Congresswomen Mikie Sherrill proposed a bill for federal funding. We completed the application and provided the appropriate information to Congresswomen Sherrill's office. As of December 2023, the expected timeline for the grant is February 2024.

The partnership with the New Jersey State Police Auto Theft Task Force Motor Vehicle Crimes Unit North proved to be very successful. Det. Alves was part of numerous high-profile cases. The Task Force was responsible for over two hundred (200) arrests in 2023. They recovered and seized countless vehicles from all over the state. Det. Alves also investigated and shut down six (6) chop shops in Paterson and many more throughout the state. Their unit also recovered numerous guns as part of their investigations. The Township of Fairfield had numerous luxury vehicles stolen from residents throughout 2023 of which Det. Alves and his Task Force recovered five (5) of them. Most importantly the one connected to a residential burglary.

Det. Bisciotti has been assigned to the Drug Enforcement Administration as a Task Force Officer. He has been involved in many significant drug and currency seizures. He has conducted narcotics investigations that has direct contact to the Township of Fairfield. Det. Bisciotti was also involved in the investigation into a crew of burglars who have been breaking into pharmacies throughout the state of New Jersey.

We continued monthly interdiction details on Interstate Route 80. These details have always been productive. It gives officers an opportunity to take part in criminal drug interdiction. The details are supervised by Sgt. Didyk and Cpl. Dean. They have been involved in the Narcotics Unit of this agency for many years.

In 2023, the Professional Standards Section transitioned Sgt. Myers into the unit. Sgt. Myers already attended initial internal affairs training and will be attending advanced internal affairs training in 2024. The workload of the Professional Standards Section has dramatically increased. Starting in 2024 the internal affairs section will be conducting updated background checks on police officers whose licenses will be expiring.

We transitioned to our new body worn cameras (BWC) system, LensLock. There have been some issues with the new system, but they are currently being addressed by the Administrative Section and management of LensLock.

The following are the year-end reports and statistics from the three sections of the Special Services Division.

5A- PROFESSIONAL STANDARDS SECTION ACTIVITIES



Their duties include conducting internal affairs investigations, drug testing, body camera and audio recording audits, officer health and wellness and accreditation.



DRUG TESTING

Pursuant to New Jersey Attorney General guidelines, in 2023, the Professional Standards Section conducted two random drug screenings of sworn personnel. In both cases, all the officers who were screened were found to be negative for illegal substances.

EMPLOYEE COUNSELING

In 2023, the Professional Standards Section oversaw the counselling of (7) officers for minor training issues.

EARLY WARNING SYSTEM MONITORING

In 2023, one officer reached the requisite number of incidents to trigger the department's early warning system. When this occurs, the Essex County Prosecutor's Office must be notified. In addition, a review of the employee's performance is conducted, and, in certain circumstances, intense supervision mandates are put in place for a specific period of time. It was determined that the officer that reached the requisite number of incidents needed intense supervision for a period of three months.

DAILY AUDITS OF BODY WORN CAMERAS/TELEPHONE CALLS

In 2023, the Professional Standards Section randomly reviewed body worn camera (BWC) videos and incoming telephone calls to the communications desk. These reviews/audits were in addition to the ones already being done by shift supervisors. Professional Standards Section personnel reviewed (1,260) BWC videos and (1,152) telephone calls.

HEALTH & WELLNESS UNIT

MEMBERS

As has been the case in the past, the chief required officers to attend the Captain Buscio Cardio Diagnostic Program or a similar screening with their own physician, in addition to their yearly eye screening. As of the end of the year, eight officers still needed to complete one or both of these screenings. The chief has extended the deadline for compliance until March 2024.

As far as defensive tactics training was concerned, everything is currently on hold until the Attorney General's Office releases their curriculum on approved defensive tactics training. There were (789) incidents of "physical fitness training" by officers during the year while on-duty.

ACCREDITATION

In 2023 the department worked on policy and procedure review. This will continue into 2024.

5B-INVESTIGATIVE SECTION ACTIVITIES

The Investigative Section proved to run effectively and efficiently with the improved table of organization. Throughout 2022, numerous investigative cases were solved or assisted from the information obtained from our department's automated license plate readers (ALPRs). These ALPRs have also assisted other police agencies with their investigations. This technological tool has proven to be invaluable to our investigations.

In 2023 the Investigative Division saw an increase of 141 additional cases. *This is an increase of 24.19%*. A majority of the increase comes from an increase in case investigations and background investigations. Detectives continued to hold drug interdiction details during the year that resulted in some narcotic and warrant arrests. In addition, with the rise in crime at some of the hotels in the Township, detectives ran special details to deter crime at these locations.

While Detective Alves was assigned to the New Jersey State Police Auto Theft Task Force, one of his cases resulted in the seizure of two stolen jeeps. The process of forfeiting these two vehicles is still ongoing but may result in the Fairfield Police Department obtaining these trucks.

The entire Investigative Section has been working multiple check fraud cases with the U.S. Postal Inspection Service. The nexus to these thefts is out of the West Caldwell Post Office which is the postal hub for the West Essex area. It is believed there is a postal employee involved in these thefts. Checks that have been mailed are intercepted and altered. The checks are then cashed throughout the country. To date the Fairfield Police have investigated over 25 cases, 21 suspects have been identified and 9 have been charged accordingly. The Fairfield cases alone have resulted in over \$400,000.00 in losses not to mention the rest of the cases outside of our jurisdiction. This case is still active with the U.S. Postal Inspection Service and the Fairfield police in an attempt to locate the suspect(s) involved in intercepting the mail with the checks inside.

Lastly, with the United States Supreme Court's decision in regard to a citizen's right to carry a handgun under the Second Amendment, it has increased the amount of handgun carry permits that have been and will be applied for in the future and the background investigations that must be conducted in association with their approval exponentially.

SIGNIFICANT INVESTIGATIONS

- <u>School Threat</u>- On January 3rd detectives assisted Florida's Monroe County Sheriff's Office by helping to investigate a school threat in Key Largo. The threat originated from a juvenile that resided on Beverly Road. Detectives took custody of the juvenile on a full extraditable warrant out of Florida and brought him to the Essex County Youth House.
- <u>Suicide</u>- On January 16th, detectives responded and investigated a suicide at 35 Harding Drive. The wife of the decedent was on the phone with the police when he apparently shot himself.
- <u>Criminal Sexual Contact</u>- On February 9th, detectives investigated an alleged case of criminal sexual contact involving multiple juveniles. The detectives worked with the ECPO Juvenile Unit and many interviews were conducted. Ultimately the case was resolved and the ECPO did not recommend charges.
- Terroristic Threats- On March 29th, detectives investigated a mass social media threat involving a former Fairfield resident. The threat included a hit list with hundreds of names on it from the surrounding area. The suspect was located, and it was determined the threat was not viable. Numerous search warrants on vehicles, locations and cell phones were obtained along with multiple interviews being conducted in order to determine there was no danger to the individuals on the list.
- Theft- On March 31st, detectives investigated the theft of packages from FedEx drop boxes throughout the Township. One of the thefts was of two Glock handguns that were being mailed by a DEA agent. This same crew hit drop boxes in other jurisdictions in New Jersey and New York. An arrest was made of a suspect in New York where his phone was taken as evidence.

Detectives wrote a communications data warrant on the phone to try and place the suspect at our FedEx drop box thefts. This case is pending along with charges.

- Narcotics- On May 17th, during a drug interdiction detail on Route 80, detectives stopped a vehicle resulting in the seizure of a large amount of heroin. The driver was arrested and charged accordingly for the possession of this dangerous narcotic.
- <u>Burglary</u>-On June 28th, detectives investigated a burglary of a residence at 8 Craig Place that resulted in the theft of a motor vehicle. With the assistance of Detective Alves assigned to the ATTF, the vehicle was located, and the juvenile suspect was charged. Detectives are still investigating this case as there was also a burglary at 299 Hollywood Avenue and attempted motor vehicle burglary at 25 Crescent Drive by the same crew that night. Charges are pending for these two cases from that night.
- <u>Burglary</u>- On August 6th detectives investigated an overnight burglary at the Speedway gas station located at 90 Route 46. Detectives did not have much to work with other than the possible description of an involved vehicle. They developed a suspect vehicle with the help of license plate reader searches. An area search through a geofence warrant was submitted and a suspect was developed through their cell phone being in the area at the time of the burglary and being tied to the suspect vehicle. The case is still active, and charges are pending.

Training in 2023 was busy yet incredibly productive. A total of 154 officers attended 77 different courses of instruction. By way of comparison, in 2022 116 officers attended 64 training classes. These courses were extra enriching and did not include mandatory training like use of force policy review, etc. Many of our officers were extremely active as instructors in various police academies including Essex, Passaic, and Morris Counties. Our instructors taught a total of 17 classes (up one from last year) to police recruits around northern New Jersey to help promote positivity and professionalism in law enforcement.




















6B-SIGNIFICANT ARRESTS & INCIDENTS

Perhaps one of the best ways to gain the proper perspective about a law enforcement agency is to examine the types of calls they are summoned to handle. Every day, our officers deal with a wide range of incidents. Some are minor and are often resolved very quickly with little need to mention them. However, on occasion, they deal with more significant cases that result in the arrest of offenders or are worth mentioning. Unfortunately, many of these calls will leave an enduring memory in the minds of our officers well beyond the time they handled it. Here are some significant arrests and incidents that they handled.

- <u>Suicide</u> On January 16th, officers were dispatched to a residence on Harding Drive for a report
 of a suicidal male in the bathroom armed with a handgun. The male and homeowner shot himself
 in the head while officers were responding and while his wife was still on 9-1-1. Once officers
 arrived, the scene was secured, and the male was pronounced deceased on scene by Dr.
 Espinoza of Morristown Memorial Hospital. The Medical Examiners Officer responded and took
 custody of the body.
- Aggravated Assault/Weapons Offenses On February 1st, officers were dispatched to a residence on Ray Place for a dispute between two males involving a knife. After an investigation, a 31year-old male from Fairfield, was arrested and charged with terroristic threats, aggravated assault, and several weapons offenses. The other male involved in the altercation was unharmed. The male who was arrested was later transported to the Essex County Jail.
- MV Violation/Mental Health Emergency On February 2nd, Corporal Lagan attempted to stop a vehicle on Route 46 East just prior to Two Bridges Road after observing motor vehicle violations. The vehicle failed to stop, exited the highway, and travelled east on Little Falls Road before stopping on Grandview Avenue in North Caldwell. It was determined the driver, a 31-year-old female from Linden, was suffering from a mental health emergency and was transported to Clara Maas Hospital for evaluation. The female was issued numerous motor vehicle summonses but was not charged criminally.
- <u>Criminal Sexual Contact</u> On February 10th, a juvenile male and his parents came to headquarters to report inappropriate sexual contact between the juvenile and a 19-year-old male that occurred in the locker room of Planet Fitness.
- Residential Burglaries On February 16th, headquarters received a phone call reporting a suspicious vehicle seen in the area of Jill Terrace. A check of the area yielded negative results for the vehicle. A short time later, burglaries were discovered on Jill Terrace, Henning Drive, and Old Sand Road. All of the residences had a rear glass door smashed and their master bedrooms ransacked. Proceeds included a safe, large amounts of cash, and jewelry.
- Felony Vehicle On February 18th, the automated license plate reader (ALPR) on Route 46 East alerted to a Honda that was reportedly involved in a shooting in Englewood, N.J. A short time later, Officer Reynolds located the Honda in the parking lot of Wawa. A felony stop was conducted and the female driver and registered owner, a 42-year-old female from Woodland Park, and her juvenile son were detained. The occupants of the Honda were determined to not have been involved in the shooting, but Englewood P.D. stated the suspect was the female's boyfriend. As a result, the Honda was turned over to the Englewood Police Department for processing.
- Commercial Burglary On February 20th, officers were dispatched to a business on Passaic Avenue for a report of a glass door that was smashed. Surveillance video showed a dark colored SUV pull into the parking lot on 2/19 just before 10 p.m. A passenger exited the vehicle, smashed the door with an unknown item, and re-entered the vehicle. The vehicle left the scene and returned later in the evening. The suspects exited the vehicle and peered through the door but never entered the building.

- <u>Sexual Assault</u> On February 21st, a female responded to headquarters to report she was sexually assaulted by an ex-boyfriend while staying at the La Quinta Inn & Suites. The female claimed she was assaulted by her ex-boyfriend while she was asleep.
- <u>Eluding</u> On February 28th, Officer Seragusa attempted to stop a pickup truck for a motor vehicle violation on Passaic Avenue. The truck failed to stop, fled at a high rate of speed, and shut off its lights. In accordance with the Attorney General vehicle pursuit policy, Officer Seragusa did not pursue the truck. The truck was later located on Bloomfield Avenue by Officer Kalinowski. The driver, a 19-year-old from West Caldwell, was arrested for eluding and issued numerous motor vehicle violations. The driver was later released on a summons.
- Felony Motor Vehicle Stop On March 1st, officers were notified of a felony vehicle entered by the Newark Police Department after it was read by the automated license plate reader located at Passaic Avenue and Beverly Road. The vehicle was wanted for an eluding incident a few days prior. Shortly after, Officer Purcell located the vehicle, a white Infiniti SUV, turning into the parking lot of 29 Greenbrook Road. The driver and owner of the vehicle, a 31-year-old female from Newark, was detained. The Infiniti was impounded back to our headquarters so Newark PD could later take possession of the vehicle for fingerprinting. It was determined the female was not involved in the eluding incident and was allowed to leave.
- Attempt to Stop/Eluding On March 4th, Officer Chen located a black Infiniti sedan on Route 46 East
 that was reportedly just involved in a shoplifting in Parsippany. Once Officer Chen attempted to
 conduct a motor vehicle stop, the Infiniti fled at a high rate of speed, entered onto Route 80 East, and
 eluded Officer Chen. To be in accordance with the N.J. Attorney General's Guidelines, no pursuit was
 initiated by Officer Chen.
 - Aggravated Assault/Weapons Offenses On March 5th, officers were dispatched to the area of Target and the BP gas station for a report of male who just threatened another male with a handgun. Upon arrival, the victim stated the male suspect entered Target with two females. The male, a 15-year-old from Washington D.C., was stopped and detained. The juvenile male was not in possession of a handgun, but after obtaining the victim's statement and consultation with the Essex County Prosecutor's Office, the juvenile was placed under arrest. An Essex K-9 responded to the scene and did not locate the handgun. The juvenile was later charged with aggravated assault, unlawful possession of a weapon, and possession of a weapon for an unlawful purpose. The juvenile was transported to the Essex County Youth House.
- Attempt to Stop/Eluding On March 8th, Officer Purcell observed a white BMW SUV exit the Caldwell Mercedes dealership in West Caldwell at a high rate of speed after a male ran from the property into the BMW. Officer Purcell attempted to stop the BMW, but it fled east on Bloomfield Avenue at a high rate of speed towards Passaic Avenue. To be in accordance with the N.J. Attorney General's Guidelines, no pursuit was initiated by Officer Purcell.
- Wanted Person On March 8th, Officer Cleary located a silver Jeep Cherokee on Route 46 East after it hit the automated license plate reader (ALPR) on Route 46. The hit showed the registered owner, a 54-year-old male from Hoboken, was wanted out of Belleville for domestic violence assault. Officer Cleary and other officers conducted a motor vehicle stop and took the male into custody without incident. The male was later turned over to Belleville P.D.
- <u>Lewdness</u> On March 9th, officers were dispatched to McDonald's for a report of male who just exposed himself to a female employee as she brought his order to the curbside pickup area. The male fled in an orange Jeep prior to police arrival. The male was identified as the same male, a 25-year-old male from Garfield, from a lewdness incident at our Target in February. The male was located, arrested, charged, and transported to the Essex County Jail.

- Motor Vehicle Burglary On March 15th, the resident of 17 Club Road came to headquarters to report their unlocked Dodge Durango had been entered in the early morning hours. A male suspect entered the vehicle and stole a pocketbook, cash, credit cards, and Apple Watch. The suspect vehicle, a black Audi sedan, hit an ALPR in town prior to it being reported stolen out of Chatham.
- Attempt to Stop/Eluding On March 16th, Officer McCormack was alerted by one of our ALPR's of a
 white BMW sedan on Route 46 East which was wanted for eluding out of Union Twp. Officer
 McCormack located the BMW and attempted to conduct a motor vehicle stop. However, the BMW fled
 at a high rate of speed into Wayne. To be in accordance with the N.J. Attorney General's Guidelines,
 no pursuit was initiated by Officer McCormack. It is believed this BMW was involved in the FedEx drop
 box thefts.
- Assist Another Agency On March 19th, officers responded to a Maple Place residence in Pine Brook after Montville PD requested our Lucas device. Montville PD was on scene of a male who had hung himself in his bedroom and were now performing CPR. Our officers assisted with compressions by using the Lucas device. Unfortunately, the male was pronounced dead on the scene by responding paramedics.
- Residential Burglary On March 20th, officers responded to a Voelker Road residence for a report of a burglary. The homeowner's son was checking on the house and found the rear sliding glass door smashed. The bedrooms inside the home were ransacked. Due to the residents being out of the country, it was undetermined what was stolen from the home.
- <u>Suspicious Person/Theft Arrest</u> On March 20th, officers were dispatched to 321 Fairfield Road for a report of a suspicious male and female. The male, a 57-year-old male from Paterson, and the female, a 33-year-old from Paterson, were father and daughter. The male was found to be in possession of two cut catalytic converters in a suitcase that were taken for further investigation. An investigation by patrol and detective bureau led to an eventual arrest of the male for theft. He was later charged and released on a summons.

Byram PD responded to the scene and assumed custody of the Toyota and placed the male under arrest for their charges. It was later discovered the male had a nationwide warrant out of California.
- CDS Arrest On March 31st, while conducting a stationary traffic detail on Lane Road, Officer Reynolds stopped a vehicle for a motor vehicle violation. After receiving conflicting stories from the driver and the passenger, consent to search the vehicle was granted by the driver. Located inside the vehicle were 50 bags of heroin, several bags of cocaine, and drug paraphernalia. The driver, a 43-year-old male from Caldwell, and the passenger, a 30-year-old female from Caldwell were placed under arrest. Both suspects were charged with numerous drug offenses. Union City reported the female is a habitual runaway and was most likely with her adult boyfriend.

Officers lost visual contact with the Acura in the area of the Fairfield Executive Inn on Route 46. A pursuit was not initiated to comply with Attorney General guidelines.

- <u>Structure Fire</u> On September 20th, officers, and the Fairfield Fire Department (FFD) responded to residence on Lane Road a report of a detached garage on fire. Upon arrival, the garage was fully engulfed and the FFD extinguished the fire. No injuries were reported during the incident.
- Motor Vehicle Theft On September 21st, an officer was dispatched to the Double Tree Hotel for a
 reported motor vehicle theft. Upon arrival, the victim stated his 2022 Dodge Ram was stolen from its
 parking spot sometime overnight. The victim had both sets of keys for the truck and glass was
 discovered on the ground where the Dodge was parked. The Dodge has yet to be recovered.
- Motor Vehicle Theft On September 24th, officers were dispatched to a Scott Drive residence for a reported of a stolen vehicle that just occurred. The victim stated after she pulled her Range Rover into her friend's driveway to drop off her children and exited the vehicle, a male exited a Mercedes and stole the Land Rover from the driveway. The wife stated as result of the strangulation, she had pain and was having difficulty swallowing. As a result, the husband was placed under arrest. The male was charged with aggravated assault/strangulation. The male was later transported to the Essex County Jail.
- Motor Vehicle Pursuit On October 1st, the automated license plate reader (ALPR), located on Route 46 East near the Montville border, alerted officers to a reported stolen BMW X7. Officer DeCarlo located the BMW, now travelling west on Route 46. An attempt to conduct a motor vehicle stop was made by Officer DeCarlo and other FPD officers, but the BMW fled at a high rate of speed into Montville. Officer DeCarlo pursued the BMW into Parsippany and onto Route 280 East before he was instructed to break off the pursuit by Sgt. Hlubik on Route 280 in the area of Livingston.
- <u>Burglary/MV Theft</u> On October 10th, officers were dispatched to an Old Country Road residence for a
 reported burglary and motor vehicle theft that just occurred. The homeowner stated while he and his
 family were sleeping, he woke up to his home's alarm system going off and called 9-1-1. A short time
 later, the homeowner discovered the suspect(s) forced entry into his home through a kitchen window,
 stole his key fob, wallet, and BMW M3. The BMW has yet to be recovered.
- Wanted Person Arrest On October 10th, the automated license plate reader (ALPR), located on Route 46 East near the Montville border, alerted officers to a Toyota Tacoma reportedly operated by a wanted person. Officer Patierno was on a detail at Target and located the Toyota in the parking lot of the BP Gas station, located at 650 Route 46. The driver, a 41-year-old-male from Wharton, N.J., and

passenger, a 41-year-old-male from Feura Bush, N.Y., were discovered to just have attempted a shoplifting at the Home Depot in Pine Brook, N.J. During a consent search, Lt. McGrory and Sgt. Hlubik located a crack pipe on the passenger and he was placed under arrest. The driver was found to have an active criminal warrant out of Emerson, N.J. and was placed under arrest. An Essex County K-9 detected narcotics after conducting a sweep of the vehicle. Located inside the vehicle was more drug paraphernalia. During the roadside investigation, it was discovered both men had committed a robbery at a Home Depot in Mahwah, N.J. earlier in the day. After being criminally charged in Fairfield, the men were turned over to the custody of Mahwah P.D.

- Weapons Possession On October 14th, Officer Reynolds and Officer Guevara were dispatched to the La Quinta Inn & Suites for an unwanted party in the lobby of the hotel. The front desk reported a male was causing a disturbance. The male, a 24-year-old male from Paterson, was later discovered to be wanted by the Passaic County Sheriff's Department for drug offenses and also have a criminal warrant out of Haledon, N.J. As the officers were speaking with the male in the parking lot he suddenly fled on foot. After a brief foot pursuit, the male complied and laid down on his stomach. While placing the male under arrest, he was discovered to have a loaded handgun, with an extended magazine (21 rounds), in his waistband. The male was processed and charged with numerous weapons offenses and obstruction. The male was later transported to the Essex County Jail.
- Attempted MV Burglary/MV Pursuit On October 14th, officers were dispatched to a Martin Place residence for a report of male who had just attempted to enter the homeowner's Mercedes. The suspects fled in a Hyundai, later discovered to be reported stolen out of Newark, N.J., and were located by Corporal Dean and Officer Reynolds on Hollywood Avenue near Horseneck Road. The Hyundai sideswiped Officer Reynolds' patrol vehicle and fled at a high rate of speed down Plymouth Street. A motor vehicle pursuit was initiated by Corporal Dean and Officer Reynolds before being terminated by Corporal Dean on Passaic Avenue in West Caldwell, N.J.
- Recovered Stolen Motor Vehicle On October 27th, Corporal Lagan observed a reported stolen
 Hyundai out of New Hampshire. The Hyundai was stopped on Route 46 West and the driver, a 30year-old-male from Union City, N.J., was arrested without incident. The male was charged with
 receiving a stolen motor vehicle and released on a summons.
- <u>Simple Assault</u> On October 27th, officers were notified of an assault that just took place at a residence
 on Big Piece Road with a white Jeep leaving the scene. Officer Guevara located the Jeep on Big Piece
 Road near Hollywood Avenue and conducted a motor vehicle stop. The occupants allegedly had just
 assaulted two males in the driveway of the Big Piece Road residence. The occupants of the Jeep were
 identified, and the victims were advised how to sign complaints with the Fairfield Municipal Court.
- Recovered Stolen MV/CDS Arrest On October 30th, Officer Wilk and Officer Perrette were dispatched to area of 175 Route 46 for a report of a U-Haul truck stuck in the grass median. The U-Haul was discovered to be reported stolen out of New York City and, as a result, the driver, a 57-year-old-male was placed under arrest. The male was then found to be in possession of a crack pipe, a BB gun, and numerous stolen credit cards/identifications. The male was charged with numerous criminal offenses and later transported to the Essex County Jail.
- Overdose On November 3rd, officers were dispatched to the La Quinta Inn & Suites for two
 females that overdosed on narcotics. Upon arrival, one of the females was unconscious and not
 breathing, so CPR was initiated and Narcan was administered to her. The other female was
 conscious but displayed signs of being under the influence. Both females were later transported
 to St. Joseph's hospital in Paterson, N.J.
- Aggravated Assault/Lewdness On November 6th, officers were dispatched to the La Quinta Inn & Suites for a report of naked male working out in the gym area. Upon arrival by officers, the male was no longer in the gym, but they located him in the courtyard of the hotel. The male, a 44-year-old-male from Lincoln Park, showed signs of being under the influence of CDS. The

male did not listen to commands and charged the officers in an aggressive/threatening manner. As a result, the officers had to use force and tackle the male to the ground and place him under arrest. It was later determined the male was a military veteran and, in addition to being under the influence, was experiencing a mental health crisis. The male was charged with four counts of aggravated assault on a police officer, resisting arrest, lewdness, and disorderly conduct. The charges were placed on a summons with a court date with the Essex County Superior Court. A screener from the Clara Maas Psychiatric Emergency Screening Services later admitted the male to the VA Hospital in East Orange.

- Prohibited Weapons/Medical Assist On November 6th, officers were dispatched to Garda, located at 210 Route 46, for a report of an accidental discharge from a firearm. Upon arrival, officers located a Garda employee, a 45-year-old male from Clifton, that was showing another employee his handgun when he experienced an accidental discharge. A different employee was in an adjacent room and suffered a minor injury from cement after the round struck the wall. The employee was transported to the hospital for further evaluation. After giving consent to search his vehicle, the male was discovered to be in possession of hollow point bullets. As a result, he was arrested and charged accordingly. The male was later released on a summons.
- Assist Another Agency On November 8th, officers were dispatched to Hilltop Drive in North Caldwell to assist the North Caldwell Police Department with a reported barricaded suicidal male who had threatened to harm law enforcement with a gun. Upon arrival, FPD units organized a perimeter around the residence and began a dialogue with the male while awaiting additional police resources. Ultimately, the male peacefully exited the residence and was transported to Morristown Memorial Hospital.
- Attempt to Stop/Eluding On November 22nd, the Montville Police Department broadcasted a vehicle involved in shoplifting from their Home Depot. Officer Purcell located the vehicle, a silver Dodge Charger with a fictitious South Carolina registration, on Route 46 near Hollywood Avenue. Once the Dodge observed Officer Purcell activate his emergency lights in an attempt to conduct a motor vehicle stop, it fled a high rate of speed. Officer Purcell did not pursue the Dodge to be in accordance with the Attorney General's motor vehicle pursuit guidelines and it was last seen entering Wayne Twp. Surrounding towns were notified of the incident.
- <u>Cargo Theft</u> On November 28th, an officer responded to the trucking depot located at the end of Evans Street. It was determined a tractor and two trailers had been stolen overnight. One of the trailers had approximately \$60,000 worth of beef inside it and the trailer was later found abandoned in Staten Island. Notification to the New Jersey State Police Cargo Theft Unit was made.
- Motor Vehicle Burglary/Motor Vehicle Pursuit On December 7th, officers were dispatched to a residence on Green Meadows Road for a male who attempted to enter a vehicle parked in the driveway. The male was unsuccessful and entered a waiting BMW that quickly left the area. Officer Ciampi located the BMW, which was discovered to be stolen out of East Brunswick, on Craig Place. When Officer Ciampi attempted to conduct a motor vehicle stop on Hollywood Avenue, the BMW fled at a high rate of speed. Officer Ciampi initiated a motor vehicle pursuit which was terminated shortly after in the area of Target once officers no longer had the BMW in sight. During this incident, officers located a purse with its contents strewn all over Hollywood Avenue that belonged to a Ramkay Drive resident. The purse was in an unlocked vehicle and most likely taken by the actors inside the BMW.



8- COMMUNITY POLICING ACTIVITIES

The Community Policing Unit is found within the Administrative Section. Once again, 2023 proved to be an extremely busy year for the Community Services Unit. The unit's mantra – *Committed to the Community* – was overwhelmingly evident as all department members were constantly engaged in community events throughout the year. This year, the department put its electric Ford Mustang into service as the Community Policing Unit's primary vehicle. It was designed to attract attention, to which it does, at every event that it appears at. The Fairfield Police Department also participated in nearly 100 events this year.

We continued our partnership with the Essex County Division of Community Health Services by hosting the Reach for Recovery mobile recovery center in the Target parking lot this year. The mobile clinic offers health and wellness screenings and a host of referral services for those battling addiction.

Officer Chiarolanza did an amazing job of keeping the Fairfield police visible and present on all social media platforms. In 2022, we reached approximately 300,000 people with our posts on Facebook. In 2023, we almost tripled that amount, reaching 810,000 and gained 1,400 new followers. In 2022, we reached approximately 16,400 people on our Instagram platform. In 2023, that number more than double to 36,000. Additionally, we gained 725 new followers bringing us to almost 4,100 on Instagram. We posted 268 times on social media this year.

A total of 177 seats were either inspected or installed at this station or other events sponsored by the department. In addition, another 41 were installed at police headquarters.
- <u>Community Meeting</u>- On March 14th, the department hosted two community meetings at the Fairfield Recreation Complex that were well attended. Topics included car thefts, home burglaries, frauds, scams, catalytic converter thefts, and home defense. We have received a lot of positive feedback from this community initiative.
- Cops in Classrooms- On February 8th, Officer Seragusa spent time at the Early Learning Center.
 He talked about being a police officer and showed the children a police car. On March 29th,
 Officer McCormack read a book to students at the Stevenson School. On October 19th, Sergeant
 Niemiec visited the Goddard School and spoke with the children about being a police officer. On
 May 18th, Lieutenant McGrory was a "secret reader" at Stevenson School for Mrs. Dillon's second
 grade class.
- <u>Senior Luncheon</u>- On April 19th, Lieutenant Tracey and Officer Chiarolanza attended the Senior Luncheon at the Double Tree Hotel.
- <u>Ribbon Cutting Ceremony</u>- On April 19th, Chief Manna attended the ribbon cutting for First Bank at 330 Passaic Ave.
- <u>Career Day</u>- On April 21st, Lieutenant McNish and Officer Chiarolanza attended Career Day at the Churchill School where they spoke to students about police work.

- <u>Tours of Headquarters</u>- On May 1st, Lieutenants Tracey and McGrory gave a tour of headquarters to Fairfield Girl Scout troops. On May 16th, Lieutenant Tracey and Officer Chiarolanza gave the 6th grade Churchill School Safety Patrol a tour of headquarters.
- <u>National Peace Officers Day</u>- On May 15th, the department hosted a ceremony at police headquarters for this day. In attendance were township officials and employees, members of the public and the sixth grade from Churchill School.
- <u>L.E.A.D.</u> Elementary School Education Program- The 2023 L.E.A.D. program was another success. The program was approximately 12 weeks long, starting in early January and ending in early May. The class of 2023 included (90) 6th grade students at the Winston Churchill School and culminating in our annual L.E.A.D. Day. A special thanks to Corporals Dean and High, Det. Cocchi and Officers Patierno and Guevara for administering the program. needed.
- Ride to School with the Fairfield Police- On June 6th, officers participated in bringing several students to school. The students were winners of this "Ride to School with the Fairfield Police" opportunity through a tricky tray event sponsored by the Fairfield schools. It was wildly successful as the entire student body from each school watched these selected students arrive at school in a police procession.
- Chief for the Day/Mayor for the Day- On June 14th, Chief Manna and Mayor Galese participated in
 "Chief for a Day" and "Mayor for a Day." Two lucky Stevenson School students won a chance to hold
 these positions. They were picked up from school and driven to town hall where they met up with the
 chief and mayor for a full day of fun.
- <u>Trading Card Program</u>- On June 16th, the department began our trading card program in town where kids collect the trading cards of participating Fairfield officers. 44 officers participated this year. The first 20 to collect an entire set will be presented with a \$100 gift card courtesy of the Fairfield Police Foundation.
- Reach for Recovery Each month throughout the year, the department and Target hosted the
 Essex County Reach for Recovery van on the second Tuesday of every month. Some of the
 services offered through the mobile services are health and wellness screenings, care
 coordination, NARCAN distribution, and community resource sharing.
- Independence Day Celebration- On June 29th, officers attended the fireworks event at the park.
- Helmet Safety Program- On June 30th, the department, in conjunction with FMAC, began our helmet safety program where children caught by police riding bikes/scooters with a helmet are rewarded with a coupon for free ice cream or pizza. Those not wearing helmets are stopped and warned. The campaign was responsible for issuing 355 coupons for helmet compliance and 22 warnings.
- <u>Junior Police Academy</u>- Between July 17th-21st, the department hosted our Junior Police Academy for the week. Twenty-four recruits attended the academy and were treated to a trip to Met Life Stadium, American Dream Mall, and the Morris County Communications Center.
- <u>Birthday Party Event</u>- On July 24th Ariya Panwala, a town resident who is suffering from a terminal disease, turned 9 years old. All members of the police department who were on duty stopped at her house to wish her a happy birthday. They even sang Happy Birthday.
- <u>First Responders Day</u>- On July 25th, officers participated in First Responders' Day at the Fairfield Summer Camp.
- National Night Out- On August 2nd, the department hosted this event at the Recreation Complex. It was extremely well attended.

- <u>Fairfield September 11th Ceremony</u>- On September 11th, the township honored those lost on September 11, 2001. A ceremony was held at the town hall and students from Churchill School attended as well.
- <u>Essex County September 11th Ceremony</u>- On September 11th, members of the police executive staff attended a 9/11 ceremony in West Orange.

- No Shave Movember/Double Down December- In November and December, the chief relaxes
 the rules of the department to participate in No Shave Movember and Double Down December.
 During these months, officers are permitted to grow facial hair that would normally not be
 permitted provided officers make a \$35 donation per month to benefit charities the department
 supports. This year the department raised \$2170.
- <u>Toys for Tots</u>- Once again, the police department spearheaded the township's participation in the USMC Toys for Tots toy drive. This drive is organized by Corporal Steven D'Argenio. The toys collected were once again distributed to underprivileged children in Orange, N.J.
